# FARRINGTON FIRED, CHARGED 'DECEPTIVE PRACTICES'

The former business office administrator of the Department of Public Works, William Farrington, has been fired. This was announced yesterday afternoon by Government House in St. Thomas, reports Associated Press.

Farrington's transfer set off a protest by 25 employees in the business office, who walked off their jobs, and also from members of the Virgin Islands Senate, who have already held one public hearing and had another scheduled for last night.

In addition to Farrington's transfer, James Francis of the Conservation Department was transferred in order to make room for Farrington and Rufus Graham of the Department of Commerce was sent to Public Works to replace Farrington.

Last week, on orders from Government House, the commissionsioners of the four departments involved stayed away from the hearing. Following this, all four were served with papers ordering their appearance at Monday's hearing. In addition to the commissioners, King's special assistant, Edward Moran was also ordered to appear.

In the letter notifying him of his dismissal "without prejudice," the reasons for his firing were set forth. Number one on the list was Farrington's alleged inability to discharge effectively his duties.

# Woman Becomes Victim No. Five

The final paragraph of the letter states that the firing "supercedes the contemplated personnel action, of which you have been previously advised, whereby you would have been transferred to the Department of Conservation and Cultural Affairs."

#### McBean Funeral Attended By 2000

The body of Edward (Eddie) McBean was laid to rest in the Frederiksted Cemetery on Sunday following service at St. Paul's Church. The funeral was attended by almost 2,000 persons. It included marching contigents of World War II veterans, U. S. Army Reserve, Boy Scouts, American Legion, firemen, police and hundreds of other persons.

The casket was carried to the cemetery on a fire engine. Pallbearers were made up of members of the Virgin Islands Fire Division.

McBean died at the Veteran Hospital in Puerto Rico following over three months of illness.

He is survived by his wife, mother and children.

# New Wage Scale Be Effective **Publication**

Wage Order No. 1 of 1969, promulgated by the Virgin Islands Wage Board and approved by Acting Cyril E. King on April 9, will not become effective until published in the Virgin Islands Registry, according to Melville M. Stevens, Commissioner of Labor.

Under applicable law, the Wage Board, which was appointed by the Governor, with the advice and consent of the Senate, is charged with the responsibility of recommending wages by industries in the Virgin Islands.

NEW YORK (AP)-Premier Robert Bradshaw of St. Kitts-Nevis says it is time that the "mouse that roared" situation in Anguilla guillans. be put to an end.

The Anguillan secession, Bradshaw said, "would also spell disaster for the entire Caribbean area," arguing that small countries becoming smaller cannot survive the realities of 20th century world political and economic

"It is inevitable that Anguilla will be dependent upon someone -be it Great Britain, the United States, the Mafia or St. Kitts-Nevis," Bradshaw said in New York after a Washington conference with British Foreign Secretary Michael Stewart.

planned by supporters of Anguillan leader Ronald Webster, who was ousted as Acting President by the British occupation forces. The British government does not recognize the plebiscite.

Meanwhile, a British official in Anguilla said there are no plans to deport any of the thirteen Americans now living on the island.

On Sunday, crowds gathered at the home of Lewis Haskings, an American who operates a small parts factory, to prevent the British from carrying their alleged plan to deport him.

It is believed that reports of Haskings intended deportation got started when Angillans spotted several truckloads of British troops heading in the direction of Haskings home. The troops, however, were checking out reports that a small cache of gun parts had been found buried in the sand near Haskings' home.

The gun parts had been found earlier by an Anguillan. Dr. Felix Spector, a former Philadelphia osteopath who went into hiding after a crowd of Anguillans saved him from deportation last week, has left the island for the French section of St. Martin. He departed from Anguilla by boat, after one day of hiding.

Early yesterday, a Scotland Yard Inspector flew to St. Thomas from Anguilla. He told Associated Press he had come "to visit friends," but it is known that several persons suspected of beating a police officer last week in Anguilla are living in St. Thomas.

A bulldozer on a trailer struck an overhead cable which caused a utility pole to split. Only the supports for the pole kept it from being knocked down.

The pole carries high tension lines and the cables for 2,100 telephones in the area, plus the distribution lines for the cable television system in St. Thomas.

As of late yesterday afternoon, utility crews were still working to transfer lines on a new pole.

day evening, Senate President John L. Maduro spoke of some of what he called the "contradictions" in the Acting Governor's address to the pub lic last week. Among other things, the Senate President referred to the statement by King that the transfer was due to a Finance Department report on Farrington, which allegedly stated that he was not doing his job properly.

Maduro asked why, if this was the case, King had transferred him to another department at the same rate of pay.

Maduro said he was very concerned about the security of classified employes in the department if "this sort of action be taken without regard for the merit system."

King's action earlier, in transferring the three men, and the subsequent issuance of letters to the 25 protesting Public Works employes, order ing them to either return to work or face disciplinary action, brought the Virgin Islands Labor Union into the picture.

The union's affiliate, the Government Employes Association, which is the recognized bargaining agent for the department employes, had called for King to temporarily hold off on his transfer order and let the situation be ironed out over the conference table.
