NOTICE OF ELECTION FOR ISLAND COUNCIL. An election will be held on Wednesday Oct. 25th to elect five members for the Island Council. Further details will be given later. Meanwhile it is important that all who are eligible to vote should have their names on the Voters' Roll. This applies particularly to those who have only recently reached the age of 21 years, and also to Anguillans who carry a foreign Forms are now available at the Government Offices for getting your name on the roll. Please apply for a form at once, if you are eligible and your name is not on the existing roll.

A new party called the Anguilla Democratic Party has been formed and is putting up the following candidates: Ronald Webster; .. Edwin Rey; .. Collin Hodge; .. Charles Fleming: .. Camille Connor: Names of other candidates can be accepted. All further nominations of candidates duly proposed and seconded, accompanied by a photograph (passport size) and a deposit of \$150 must be handed in to the Retiening Officer, Mr R.T. Lake between the hours of 9-12, and 1-4 on October 17th.

Note that candidates need not reside in the district for which they are standing. Note also that Civil Servants are eligible as candidates.

HOSPITAL BOARD. A hospital board has been appointed consisting of these members. Medical Officer (Chairman) Ronald Webster, Edwin Roy, Emile Gumbs, Atlin Harrigan, Campbell Fleming (Secretary). . At the first meeting of the board on Oct 2nd, it was decided that:-

Staff Nurse Adams be transferred from the Hospital, to be in charge of the Clinic at the East End, and Mid-wife. The vacancy caused at the Hospital to be filled by Staff-Nurse/ Midwife Gwendoline Hughes aged 26 of South Hill.

In view of the shortage of midwives in the Island Harbour area, an application Mrs Thelma Hunte of Island Harbour to practice midwifery in that area was

approved and permission given.

A post of Hospital Maintainance Officer was created, with responsibility for the smooth running of the hospital in all its departments. Mr Campbell Fleming, a trained male nurse was appointed to this post.

EDUCATION BOARD (amended notice) At a recent meeting of the Council it was decided to create an Education Board to handle such matters as, Employment of Teachers, Salaries, Vacations, Increments, Bonuses, Retirements etc. The Board is composed of The Headmaster of the Secondary School (Chairman and Convenor); Two teachers chosen by their fellow teachers; two members of the Gouncil; and the Rector of Anguilla, or the Methodist Minister.

PROPOSED RADIO STATION Development of the proposed 100,000 watt Radio Station took on a more concrete form this week, with the Council's approval of a Letter of Intent, drawn up by the Canadian Firm. More complete, and embracing a wider field of benefits, its contents disclose the following:-1. A sum of \$65,000 will be paid to the Government of Anguilla upon the signing of the Letter of Intent by Mr Ronald Webster. 2. The Letter of Intent includes many other benefits which will be presented more completely in forthcoming issues of this paper. USA RESUMES PARCEL POST TO ANGUILLA. Parcel Post) Dispatches for Anguilla will be way-billed for discharge at Philipsburg, Saint Martin, instead of via St Kitts as heretofore. The last despatch of parcel post for Anguilla was No 14 via St Kitts. The Parcel Bill numbers for Anguilla will continue in numerical order. A duplicate copy of the parcel bill concerning each despatch will be sent by mail to the Postmaster, Willemstad, Curacao, N.A. for accounting purposes. Copies of this bulletih will be sent to Curacao and St Kitts for information. The Chairman of the Council was informed to-day by the Postmaster of Anguilla that the first parcels have reached here from New York, via S Martin.
