EDIFORIAL. anguillans are rightly rejoicing at the temporary settlement that has been found to thier dispute with St Kitts, and are very grateful to the Parliamentary Delegation for what they have achieved, but we consider at our duty to remind our

pelegation for what they have accepted, but we consider at our day to remind our readers, that this is not yet Victory, nor yet a permament Peace Settlement, but only an Armistice, even though heavily weighted in our favour.

Britain only stepped in at the invitation of the Government of St Kitts, and the Government of Anguilla. And while Anguillans are determined that by the end of the interim period, their divorce from St Kitts will be made absolute, the final sevene of Anguilla from the State of St Kitts can only come, and we hope will come, when St Kitts finds that she can live more happily without us, and their House of the final sever-Assembly votes to cast us off; or if the Constitution of the State be withdrawn. We hope to publish next week a full text of the Agreement, approved and signed by the Council and by Messrs P Adams, E Gumbs, L Wilson, W Hodge, and the members of Editor of this paper, committing all Anguillans; just as it has been signed by Mr Bradshaw, committing all in St Kitts and Nevis. What we have gained will then be

known by all, and also what we have not yet got, and have still to fight for. INTERIM SETTLEMENT FOR ANGUILLA. On Monday afternoon Dec: 18th the Parliamentary Delegation announced in Eurows Park that a general agreement had been reached, which would be in force for a year or so. Mr Ronald Webster opened the meeting by introducing the two M.F's as "fellow Anguillans" to the cheers of the crowd.

Mr Nigel Fisher.M.P. thanked Anguillans for their warm welcome, and announced the the Settlement to be in effect in the interim period. This settlegeneral terms of ment is subject to final approval of Her Majesty's Government, and leaves all legal questions unresolved. H.M.G has agreed to many of the requests of the Anguillan Government, but has left most questions to be worked out during the interim period. Mr Tony Lee will be designated as the Senior British Official on Anguilla. He will assist and advise the council, and help to work out a permament solution, satisfactory to all. H.M.G will be responsible for external affairs and defence. Mr Lee will be and report direct to H.M.G in London.

Mr Donald Chapman, M.P. made it quite clear that the interim arrangement does NOT mean the return of Anguilla under St Kitts. He hoped, with Mr Lee's help, that Anguilla would receive British and other money, much already promised, for development assistance for the roads and airport and other projects, and was sure that when he visited Anguilla again in two years time he would see many changes (Loud cheers) The Parliamentary Mission had obtained Mr Bradshaw's invitation to H.M.G to designate a Senior Civil Servant to work on Anguilla for an interim period of a year. The meeting then broke into song with the strains of ""We are out to build a new Anguilla". Anguilla". When quiet was restored, Mr Tony Lee was introduced, and said that he was eagerly looking forward to being in Anguilla and helping to work out its problems Roger Fisher then spoke. He emphasised that the interim arrangement ws not a hal solution to Anguilla's status, or to the many legal problems that still exist It was a step forward, a big step forward. It was now possible to work on these questions with Mr Lee's help. No party, either St Kitts or Anguilla had been asked to abendon its legal position.

Mr Webster and the other members of the Council then spoke briefly, thanking the Parliamentary Mission for the success of their efforts, and reminding Anguillans that we were still faced with a serious financial position, and called on all Anguillans inside and outside the island to continue their efforts to help Anguilla. The meeting then broke up, and all went away with thankful hearts. A Steel Band took the street in a jamming session, went up to Island Harbour, and back to "Tropical Flower where they danced into the wee hours of the morning.

OUR NEW BRITISH CIVIL SERVANT. Tony Lee who is now living and working with us here in Anguilla, was born in England near Stratford on Avon in 1923. His father was a country Rector of a parish of 400 people with two churches. Even now to visit his home village of Whitchurch, one has to get out of the car, and open (and close) a gate across the road. He was educated at Stratford on Avon, and at Shrewsbury School. Later he went to Magdalen College, Cambrid 9. During the war he was a Lieutenant in the Royal Navy, serving mostly in Motor Torpedo Boats in the North Sea.

In 1948 he went to Tanganyika in Africa, now known as Tanzania. There he was a district Officer and a District Commissioner, where he would have been called the "Bwana Hkubwa" (Not a bad name to call him by here, which means "The Big Man") He also served as Clerk of the Exective Council and the Legislative Council.

He left Tanganyika in 1962, and worked in Birmingham, England for two years in the Motor Industry. In 1964 he returned to public service, and was posted to the Office of the High Commissioner in South Arabia, at Aden, where he served till very recently. He is married and has three daughters. He is hoping to find a house in Anguilla

which will be near to his work, where his wife can come and join him next month. The BEACON extends a very warm welcome to Mr and Mrs Lee, and feels sure that he is the right man for the job, and that he will work in harmony with the Anguillan council, and will be their spokesman to her Majesty's Government in Britain, and will be so identified with Anguilla that he will rejoice with them when a final settlement is achieved.

THE BANK OF AMERICA COMES TO ANGUILLA. Not the least of our difficulties in the past six months have been the restrictions placed on the National Mid-Atlantic Bank in Anguilla, because it is a branch of the parent Bank in St Kitts.

This week a delegation representing the Bank of America, with Headquarters in San Francisco started negotiations which we hope will bring this well established and respected bank to our Island. Plans are being worked out whereby Anguilla will have at least one thomoughly reliable Bank, which will buy up all the assets and liabilities of the National Mid-Atlantic Bank, and make use of the present Bank buildings, and the present Bank Staff. This is good news for Anguilla, as we will no have a bank that is completely independent of St Kitts. Mr Rogers has in his safe keeping all the Ledgers of the "St Kitts-Nevis-Anguilla" Treasury Savings account, that concern Anguillan investors, and as soon as possible, hopes to be able to pay out deposits that had been frozen in that account. Notice will be given in the EEACon when this can begin.

CORRESPONDENCE. Sir, Please clarify your reason for publishing a Government Notice, after the publication of the Beacon on Dec: 16th. After hearing the Public Meeting on the Park last monday, and the agreement that was reached, I conclude that nothing was wrong at all with the statement in the Editorial, which said that "Anguilla, St Kitts and Nevis would work together in the framework of the State. The agreements reached are only for about a year, at the end of which it takes Mr Bradshaw to agree to any new proposals. If this is not so, how come that he can say that any one in St Kitts found with Anguillan stamps will be prosecuted. If I am wrong, I suggest that he shut his mouth for one year. signed Anguillan, Anguilla.
