EDITORIAL. In years to come, a student of the history of Anguilla will be able to identify various mile stones on Anguilla's path from St Kitts to a recognised independence. The first of these was the issue of special Anguillan Stamps, and their recognition by the world; the second, the Nationalisation of Oil and Gasoline; the third, the coming of the Bank of America. Each of these achievements was a break out from a stranglehold that the Government in St Kitts had obtained over us; over our mail; our oil; and our money. Each of these achievements has left Anguilla in a far more healthy economic condition than ever before.

The next three milestones should be, 1. The obtaining of a Judiciary, independent of the Government and of undisputed legality. 2. The implementation of the scheme wherby Anguilla receives a grant in her own right from the Overseas Development Corporation, 3. The receiving directly from Her Majesty's Government Anguilla's share

in the block grant made to St Kitts Nevis & Anguilla.

The matter of the Judiciary should be the immediate major concern of the Government. We hope that they have already a bulky file of corresondence with the High Court in St Lucia on this matter, requesting them to appoint a magistrate for Anguilla. The present court, presided over by a Justice of the Peace, was appointed by the Anguillan Government, and has done much useful work in punishing and restraining petty crime, but it has no more and no less legality than the body which appointed it, and which itself (pending recognition) is only there ecause it is the will of the people. Until we have a proper judiciary, the Government can do no legal business, nor transfer land, nor can a proper inquest be held. The matter has been brought to a head by the presence of a man in the police cells, comitted for trial on a charge of murder. He has been in the cells for two months, and his case is no nearer being heard than it was on January lst.

We can well imagine what is happening behind the scenes. Anguilla has no doubt applied for the appointment of a magistrate, but such an appointment must have been circumvented or held up by Mr. Bradshaw, . who is the Premier of St Kitts. He understandably is loth to let the gap Metween St Kitts and Anguilla grow wider, by giving Anguilla any recognition or approval of its "rebellious condition".

Meanwhile Winston Browne is beginning his third month in the prison cell.

What is happening to our Council Members? How many more pieces of bad legislation will be passed, Can not any of them think before they make a move? It should be impossible for all the members to make the same mistake: surely some of them can see the danger of certain bits of legislation? If this is so, someone is trying to put the Chief Executive into a position where he can be exposed to open criticism. Every one is looking to this man for leadership; and he is looking to his fellow council members for ideas and help.

It is hoped that the Chief Executive will not delay to set up an Advisory Board, as he promised to do at the famous meeting in Burrows Park on February 4th. This might eliminate the danger of being pushed over the brink by persons, who think that they know the ropes, and playing round with the future of the island and its inhabitants. There is still the need of Council Meetings held in public. There is still the need to seperate the Civil Service from politics; there is still the need for officials and politicians to show good examples

We have pointed out already, that no legis what is afoot, and when it will be passed. This would save time and labour on legislation, instead of finding out too late that it will not work. Thus the Council would
have the opportunity to test the reactions of the people, before rts final passage.
We also wish to make it clear that we are not ruling out the privilege of the Council
of Anguilla : to make laws when they see it best for the people.

THE NATIONAL MID-ATLANTIC BANK PURCHASED BY THE, BANK OF AMERICA The National Mid-Atlantic bank of Basseterre, St Kitts has been purchased by the Bank of America, the world's largest commercial banking institution. Negotiations were completed this week for the acquisition of this Bank, which will become part of the California-based Bank's world-wide banking organization. The announcement of the change of ownership was made jointly by Mr A H Brawner, Bank of America Vice President, and Mr Marcel Goyeneche, Managing Director of the Mid-Atlantic Bank. Speaking on behalf of the new Owner, Mr Brawner commented that the bank will emphasise expension and development of local economy in its fins cial transactions. "Although we will extend financing to the export-import activities so necessary to the economy of the islands, we expect to make a major contribution toward developing their agricultural, industria; and commercial potential" said Mr Brawner.

The purchased bank with branches at Basseterre, and Sandy Point in St Kitts, and

The purchased cank with oranches at basseverre, and bandy roine in St Kitts, and in Anguilla has assets of ECS2,350.000 Full responsibility for the bank's deposits and liabilities will be assumed immediately by the Bank of America.

The Purchase of the National Mid-Atlantic Bank represents the banking organization's first direct presence in the Bastern Caribbean..it has branches throughout western Europe, including two branches in London and one in Birmingham.

That may be so, but I can bet Mr Bradshaw that though he may have the biggest bank, he will never get Anguilla back under his control.

According to that speech, one might think that he can mortgage or sell the Government's land in Anguilla, but I can assure you, that according to this Government's agreement with the bank, the Anguilla branch is completely seperate from that in Basseterre. The main branch controlling Basseterre and Anguilla is situated

in St Croix, and of course, the main offices are at San Francisco.

HOSPITAL BOARD NEWS Shortage of nurses in Anguilla has for years resulted in long HOSPITAL FOARD NEWS SHOTTAGE OF MITTERS IN ABGULITE HAS LOT YEARS LEGALITED IN 10118 hours of duty for the hospital staff, and the closure of our Health Centres for much of the time. However, as a mesult of a letter written to the Times by the Rector and the Doctor, OXFAM, the British Relief Organization has offered to send us two experienced nurses, oth of whomere qualified midwives. They are Miss Lavinal de Sarigny, and Miss Miriam Hughes, and they have offered to serve in Anguilla for the next 15 months, and are due to arrive next week. As a result, it is hoped that all of the Health Centres will be open daily, and that a qualified midwife will be available to serve each district of the island.
