representative of the Bank of America and read out by him to a public meeting in the Park on March 8th. "The Following is a statement that should be broadly published in Anguilla Newspaper and other media that- The Bank of America has purchased controlling interest in the National Mid-Atlantic Bank and intends to convert the offices of the N M-A B to branches of the Bank of America. Each of the offices will be under the direct supervision of the Bank of America in San Francisco, as is the Bank's normal practice --- the same message is being sent to St Kitts" signed George Kroetz, District Operations Officer, San Francisco. This telegram and the public meeting made it clear that: 1. The Anguillan branch of the bank will be directly under San Francisc and not under St Kitts. 2. That the Bank of America has told St Kitts to correct the misleading advertisement in the Democrat. 3 That for the last nine months, although St Kitts Government did its best to close down the bank in Anguilla, it was only by the determination of Mr Clifford Rogers the Manager, that the Bank remained open, but if at any time there had been a run on the bank, it would have had to close its doors. 4. The Bank of America guarantees now all the liabilities of our Bank, and is sending cash for that purpose. 5. The final contract between the Bank of America and the Anguillan Government has yet to be signed,, but until that is done our Government approves that the Bank of America works here. The BEACON comments. It was on the advice of Dr Roger Fisher that the Bank of America was invited to work in Anguilla under these four conditions:that 1. Anguilla's bank should be completely independent of St Kitts. that 2. The Bank of America take over all assets and liabilities of the N M-A B in Anguilla, that 3. No Anguillan would be penalised for non-payment of interest on loans during the difficult times, and 4. The Bank of America would sign a separate contract with the Anguillan Government before finally taking over. Mr Ronald Webster and all the Council members up to last sunday were quite satisfied by this agreement. What has caused alarm is an untrue and misleading advertisement in the Democrat. According to international law the only way the Bank of America could have bought up the National Mid-Atlantic Bank was to buy all three branches as one lot. This has been done. Now they must come to Anguilla and sign an agreement with the de facto Government here for permission to operate. The sconer this can be done, the better. All was going according to plan made by Roger Fisher, but we consider the Government could have done more to allay the fears of the people, and have stood firm by the decisions they had made, and not to have been swayed thenselves by an irresponsible advertisement. Surely Anguillans have learnt by now not to believe everything that emanates from St Kitts. international bank here and now. If it should go, the door will be wide open for any We need this reputable privately controlled bank which would only bring crooks to Anguilla.

He told the audience that though he thought he could do a better job by trying as welfare officer to get people to settle their disputes before ever they came to court, he had agreed to accept the post of acting Magistrate, because some one had to do the job. THE JEKYLL and HYDE OF ST KITTS. The following is an article published in the London Evening Standard Of Feb: 22nd, written by Lord Lambton M. P who recently visited Anguilla and St Kitts.

"The last island I visited in the West Indies was St kitts, from which another island, Anguilla seceded last year, demanding independence. All over the Caribbean rumours had reached me of extraordinary occurences in St Kitts, coloured by the activities of Mr Rradshaw its Premier, who was reported to be extremely eccentric. I was informed that he was frequently to be seen in the uniform of calonel of an imaginary regiment, pistolled and besworded, riding in the back of a vintage Rolls Royce. So looking forward to our meeting, I was surprised to find a charming dignified and gentle man, who looked as if he has never seen a uniform in his life. I had a long talk with him in which I tried to ascertain whether he was worried by the fact that his Government had become labelled as notorious in the Caribbean, and that it was generally conceived that he was a quasi-dictator determined to drag his island down to the level of the Haiti regime.

Mr Bradshaw realises this fact, resents it, and conceives that he is the victim of an international conspiracy aimed at his destruction. This is peculiar, for the reasons for

Mr Bradshaw's Caribbean reputation are obvious.

The Leader of the Upposition had been thrown into prison for opposing, and has now fled the country. Others, for no greater crime than writing a letter criticising the Government have also een imprisoned. The trial of prisoners was a parody of any of justice, and was condemned by the West Indies Judicial Authority. Mr Bradshaw's position is also totalitarian. He is not only premier, but president of the sugar-work ers union, and at the same time controls the police. In other words, his rule is not only tyrannical but authoritarian. Why should he be surprised that it has caused such resentment in the other Caribbean associated states, who are striving to maintain a democracy and the rule of law? The answer probably is that there are Two Mr Bradshaws.

One is the elegant and urbane ex-federal minister, who can justly take pride in having achieved the high standard of living of the Sugar workers in St Kitts, whose allegience he retains. The other Mr Bradshaw is a Mr Hyde, who appears at times to be really unwell and who, if he took advice from an impartial medical board, would almost certainly be advised to retire from public life. For his health has caused him to have delusions not only of grandeur but also of persecution, which has made him a ready tool for some of his advisers who are rapidly and richly feathering their nests to the island's detriment. These advisers are a peculiar assortment of men. One has a quaint background for such a post- a conviction for assault battery and foul language.

Another personal adviser is an even more alarming character, an extreme racialist and friend of Kalcold X, he is stirring up the dormant colour problem, and undermining position of the sugar growers upon whom the economy of the country depends. He obviously Mr Bradshaw's Iago, and appears almost to wear on his sleeve the precept "I

follow him to serve my turn upon him'

Nor are these advisers exceptional. Indeed, they all appear united in pushing Mr Bradshaw towards a declaration of a one-party state. St Kitts is a sick and unhappy island, and Mr Bradshaw's future policies will embarass the British Government, which remains responsible for the island's defence policy. Nor will the recent agreement, made by Mr Nigel Fisher and Mr Donald Chapman, to postpone for a year the question of Anguilla's secession help matters. For conflicting impressions are held.

Anguilla believes that its independence has been established. St Kitts believes that Anguilla will be returned to it by the British Government at the end of the year. A settlement based on such a misunderstanding will do more harm in the long run than a elear unpopular decision would have done now. Its most likely long-term result will a elear unpopular decision would have done how.
