

EDITORIAL.

The Government in St. Kitts have again lost their heads, and have recent taken two steps which are going to do them no good, either in the eyes of the world, or among their own people. They have taken strong action against Mr. Jones, Headmaster of Basseterre High School, which has roused the wrath of the teaching staff throughout St. Kitts and with them the Civil Servants. They have also taken the very rash action of arresting the Editor of the Democrat. She has been released on bail pending a hearing, but this is in itself a very dangerous action. And prevented public meetings he has kept Z.I.Z. for his own propaganda, but so far he has failed to muzzle the press, (except that the Beacon is not allowed in St. Kitts).

Whether in St. Kitts or Anguilla, the same principle is at stake, The people may not have the ability to speak or write what they are thinking, they can only talk. Their talk represents their wishes, whether right or wrong. The only to find out what people want is to appeal to them, so that each individual will have an equal method of expressing his views.

In the case of St. Kitts, the Government there, to be honest, ought to go to the people amd have an election, and really find out what the majority of the want. In the case of Anguilla, if a matter is coming up which affect the peoples' whole future, the people must have the opportunity of expressing their wishes in a referendum. Public meetings cannot really assess the people wishes, because half the people do not attend public meetings, but that does not say they are not interested, or that they have not an equal right to express their opinions as some of the more noisy ones. There seem to be a vital issue before us, which, whatever the Government in Council decides, has eventually got to be put to the people. Do we want to cut the ties with Britain and go independent at this stage, or do we want to go on trying to negotiate a settlement that will give Anguilla her independence on a sound basis? At the same time not losing the good will of the Commonwealth nations.

The advantages and disadvantages of both views must be digested by the people before they decide. The line the Beacon has taken, whether right or wrong is known by all. The other side must have an equal chance to to put their point of view. It is regretted that the "Observer" has ceased to function, because when opinion is divided both sides should be clearly stated. The Beacon wants the people of Anguilla united, and as an independent paper, makes this offer to the Government. We as the only paper on the island at this time are prepared to offer up our space in the Beacon to the Government or the members of the Council to state their cases. We agree to print whatever they give us, so that when the matter reaches the stage of referendum, people will know what they are voting for.

The following is a statement

by Chief Executive Ronald Webster.

CONSTITUTION OF ANGUILLA.

A brief explanation of the Constitution of the Republic of Anguilla to be presented to the people for their approval on a date in the very near future is given here to show the substantial fundamental rights guaranteed and the composition of Government to be enjoyed. Unfortunately space does not permit the entire text to be published here, but copies may be obtained from the Beacon for \$1.00 E.C. (\$.50 U.S.)

An organised society cannot survive without a foundation of Constitutional Law designed to ensure the people all personal rights of God, Life, Liberty, Freedom, Justice and Property. It must be a representative form of Government expressing the will of the people to the guaranty of equal rights.

It cannot be oppressive to man's dignity, nor can it be repulsive to his

This Constitution encompasses the territory of the Islands of Anguilla, og Island, Scrub Island, Sombrero Island, and the small islands and cays arrounding them. They shall henceforth be known as the Republic of Anguilla. The fundamental rights guaranteed include political rights, right to trial y jury with the courts open to all persons, Religious Freedom, right to sail, Freedom of Speech and Press, right of Assembly and Petition, prohibition against imprisonment for Lebt and unreasonable search and seizures and equal protection of the Law.

Citizenship includes all persons born in Anguilla and their minor children. There shall be a distribution of powers and the Government shall consist of three departments; Legislative, Executive and Judicial. The Legislative shall consist of 11 members, six selected by district and five elected actionally, all by popular vote. The Executive Branch shall be a President and Vice- President, elected by popular vote, and such Cabinet members required to facilitate the operation of the Government. The Judiciary shall consist of three Supreme Court Judges and a system of inferior courts to the chear all civil and criminal matters. No person serving in one department (Legislative, Executive & Judicial) can exercise any powers in another execpt for the checks and balances provided in the Constitution.

To ensure understanding by the People of Anguilla and these abroad, complete copies of the Constitution will be distributed as follows: 300 copies will be given at the meeting in the Park on Sunday 2nd, February, 50 copies will be sent to St. Thomas, V.I., others will be sent to various places abroad. Copies will be posted at public buildings throughout Anguilla

It matters not the number of those oppressed if they constitute the whole of the people, for their right to human dignity cannot be based upon the justification that they are too few to speak with the strength of the mighty History has proven the concept of man's will to throw off the yoke of tyranny when that burden is no longer bearable and the clouds of despair are without end.

Our future course, is not so much dictated by desire for the difficult road of Independence, but necessity, inflicted by those who refuse to grant any measure of relief acceptable to our good conscience. Our choice cannot be one of continued oppression by dictatorial power and abandonment in a changing world, nor can we remain indifferent to our circumstances without hope for a better way of life.

The goal of the People is to establish an exemplary form of Government and demonstrate to all Nations that man can enjoy the rights of Freedom, Justice and Liberty in pursuit of a better way of Life with Devine


According to reports these two men arrived at Cay Bay Friday night in the small fishing boat. The men refused to give to the Police any information whatsoever; saying "We will only give information to the Police in St.-Kitts". The Police Dept. here upon checking with St. Kitts was informed by the St. Kitts Police Dept. that the boat was stolen from Nevis. The men were both about 25 years of age and had no money when they were held by the Police. The Police here sent them back to St. Kitts by plane. The owner of the boat flew in on Tuesday, identified the boat as his and then returned, at press time the boat was still here. There is much speculation here that there were more than two men in the boat and that they were commissioned by the St. Kitts Government to go to Anguilla. Some people from the area say that they have seen more strange men in the vicinity.

A notice was broadcast over Z.I.Z. that a boat was missing from Nevis. It is reported that the description matches with the boat. It is believed that Z.I.Z. broadcasted this notice, with an attempt to cover up for this boat in event it failed to carry out its assigned duty, which was an attempt to land these men on Anguilla. For some weeks now, it was known that certain men from St. Kitts, some former police stationed in Anguilla prior to 30th. May 1967 were in St. Martin on some assignment. These men were being watched and reports of their activities were reported back to Anguilla. A stelly watch is being kept in Anguilla for this type of invasion from St. Kitts. The Anguilla Defence Force has been disappointed because these men were apprehended in St. Martin.

Visit of the Bishop of Antigua (Branch) to Anguilla. On Wednesday morning March 14th, 1888 we left St. Barths for Anguilla, and after a tedious voyage of many hours were landed on the East End of Anguilla, in a sailing boat sent on for the purpose by the Rev'd C.A.Shepherd the Rector. Our schooner meanwhile went round to the usual anchorage at the other side of the island. At the East End the Bishop and party visited the site of the proposed church there, which had been in contemplation for many years, but is likely now to be brought to completion by the energy of the present Rector. The Bishop decided that the whole of the walls given to the Church by Dr. Fleming, which were originally an old family mansion, should be used for the purpose. The people have promised much help in labour lime, etc. After reaching the other side of the island in the evening there was a service when Mr. McConney preached to his old flock. It did one's heart good to see how delighted they were at the short visit from their former clergyman. Next day there was a Confirmation, at St. Mary's when 43 were confirmed in the presence of a large congregation, who had assembled in spite of a heavy downpour of rain before the Service. We

observed with pleasure the many improvements in St. Mary's Church. The day school was visited, which is well taught by R. Maguire, who was one of the fifth form boys in Antigua Grammar School. Maguire's master and schoolmates will -be glad to hear that he is highly esteemed in Anguilla, nor will they be sorry to know that he keeps up the traditions of the Grammar School to the extent of having introduced cricket among the Anguillan boys. We left Anguilla on Saturday morning, finding some little difficulty in embarking, owing to a ground sea from the north, which made it ticklish work to get into the boat (pulled up on to the beach) whether by leaping into it, or by the more ignoble process of being lifted up bodily and being put into it. Saba was reached after a quick voyage of some six

Letter presented for publication by Chief Executive R, Webster. Chief Executive

Members of Council Gentlemen, 17th. Jan. 1969.

The situation here in Anguilla is again in a state of uncertainty, and therefore, I suggest that the council relax from the views of H.M.G. and the others, and let us organise ourselves, because we cannot undo, what is already done, and not for a moment must you feel that you have made a mistake. Britain and the Carribean Countries are not willing to cope with us, we must find ways and means to survive, and forget our short comings, because every individual in Anguilla know that to unite with St. Kitts again, will in no uncertain terms be the end of all freedom for Anguilla.

I am therefore making these following proposals to the Council. Since Britain remains in charge of external affairs and defence, we should accept investors now. Don't wait for anything. 2. Pass a wage law, and tax all employees of both government and private businesses. 3. Taxes for houses, lands, boats etc. should be paid up to date 4. Strengthen the police force, in order to crack down on vandalism, which already has caused the destruction of Government Property. 5. Encourage our people to make use of the bank. 6. Erect a temporary market place in the Valley, so that our people can sell their over- flow of vegetables, meats fish etc. 7. Control he Taxi Fees, and track down those who over charge, and Taxi in private ears. 8. Provide Island wide transportation especially in the early hours of the night, this can be arranged by those who own Volkswagon buses. 9. Encourage our local people to invest in small business in the Valley, such lift Shops, Liquor Stores etc. for tourist attraction. 10. Appoint a committee to study the entire development of the island. 11. Do all you can to make the Valley look like the capital. 12. The Council should inform the public regularly of the latest developments on the island. I wish to assure you gentlemen that we all share the problems of Anguilla, and there is much more private discussions as how to solve the problems, than public conferences. We are all grateful and thankfull to the Chief Executive, and his Council for your voluntary services, and may you all continue in Unity, and you will have the support of every true Anguillan.

DELEGATION OF AUTHORITY (By Christopher Romney)
Authority Commensurate With Responsibility.

The Supervisor as a leader require authority consistant with his responsibilities. It is desirable that each leader have a clear realization of his duties and responsibilities and the extent to which he may exercise authority. (a) The line of organisation and the scope of authority to be exercised by each leader must be clearly defined. (b) Similarly, each leader should be specifically and clearly informed as to his responsibilities, his duties, and the extent to which he may exercise authority. (c) The duties and functions of each leader hould be clearly stated in writing. Too frequently, it is assumed that leaders understand their duties and the full extent of their responsibilities. Failure to make sure that all supervision is fully and accurately informed on this score leads to confusion, misunderstanding, and dissatisfaction. (d) The use of an organisation chart is a desirable method of emphasizing the line of authority between departments and divisions thus eliminating the

possibility of conflict and overlapping.

EDITOR ARRESTED.

Miss. Vivienne Fieulleteau Editor and Publisher of the "Democrat", St.Kitt only Opposition newspaper was arrested by the police at about 2.40 p.m. on Monday, 20th. January, while at her work and charged with "Public Mischief" The charge is in connection with an article entitled "Unsolved Nevis Murders! Why? Written by "Questioner" and published in the Democrat on November 30th. 1968.
