RADIO ANGUILLA.

The island's own station, Radio Anguilla, went on the air on Wednesday evening. It took just eight days for Engineers from London- with the assistance of a local contractor Royal Engineers and Paratroopers - to unpack the equipment, erect the two 120ft. aerials and set up the radio station in a store at the back of the Agricultural Office. The studio still lacks a coat of paint and other refinements but the station went on the air just as soon as the transmitter was operating. The signal is coming through loud and clear on 15.10 Kilohertz (kilocycles) in the medium wave. We have not yet had reports from St. Thomas but the station's power of 500 watts should ensure that it is heard there also. From the start, three Anguillans- Vanier Menes Hodge, Lirda Banks and Ralph Hodge - Have been announcing on the radir At present the station is broadcasting from 6.30 until eight 6'clock each morning and from six thirty until eight each evening. Programmes consist of music, relays from the BBC and two local news bulletins each day. This radio station, which the Beacon welcomes, as a valuable sister medium of communication on the island, surely demolishes the argument of those who claim that the development plans are bogus. It should play a very important part in keeping the island really well informed, and cut out the rumours that has been doing this island and its people more harm than good. Anguillans in the nearby islands will now be able to get latest happenings on this island first hand.

DENTAL NEWS.

Working in the Dental Clinic for the past three weeks is Dr. Everett Claus, an Oral Surgeon, who arrived here with Dr. Nicholson of Puerto Rico three weels ago and has been wery busy at the Clinic caring for at least thirty patients in one day. Dr. Claus is Vice President of Christian Dental Soc. of Arizona. Like the Methodist Mission in S.C. who has been sending Medical Surgical Doctors to Anguilla simce November last year, the Society pays all expenses to Anguilla and hopes to send other Dentists in the future. The Society is interdenominational and helps people all over the world, Dr Claus said he did Mission work in India last year. He is accompanied by his wife and Grandson.

BACK TO SCHOOL

The Valley Secondary School will reopen on April 14th. The School was closed on March 18th for the Easter Holidays. It has been occupied by the British Paratroopers as of 19th March, when they landed and took over the island. The Royal Engineers have been very busily painting and putting the building back in order for reopening.

PREEDOM OF SPEECH AND THE PRESS.

Last issue of the Beacon we reprinted a press release on page 5. This was clarify a misunderstanding circulated in Anguilla, that the Beacon press belonged to the people of Anguilla. The following is a release that did not get printed last week due to lack of space. On Wednesday 12th March, the day after Mr. William Whitlock was expelled from the island, eight men, some armed, walked into the premises of the Beacon and took away the Beacon Press. Spokesman for the men said that, they were sent for a press which belonged to the people of Anguilla. My wife and her mother who were home at the time, did not argue with the intruders who took the press away. On hearing this, I approached Mr. Webster who said that he had no knowledge of what had happened. Mr. Webster returned the press the following day, with an excuse for the men. It said "The press was taken by citizens who believed that the Beacon printed news that was treasonable". The press was out of order when it was returned. Thanks to two persons a new roller was brought in from Boston, on Saturday 29th March. The Beacon holds no ill feelings against these men. We feel that the press was taken as a result of a meeting held at Sandy Hill's Gov't Building the night before, by some Gov't Officials.Mr. Jack Holcomb and Mr. Jeremiah Gumbs were also present at the meeting. RUMOURS.

This newspaper has received complaints from Anguillans in the V.I. against the British Commissioner. The allegation reportedly rumoured in St. Thomas, are in some cases deliberate and untrue. To put the record straight, we print the following facts as reported by Commissioner Way, Chief of the Anguilla Police Unit, and confirmed by Sgt. Ryan of Anguilla April 9th. 69. NO cases of rape by troops were ever reported. Assualts by two troopers on two women were dealt with by Military court, as a result the two men were sentenced to 28 days detention each. They were later forgiven by the two women, after they realised the punishment they received. One man, Edgar Harrigan, reported that the Troopers had taken from him \$201.00 U.S. This was denied by the Military. Vehicles had been searched and stopped at nightstwo persons had been detained for questioning, another Dr. Spector who do not qualify to hold a licence to practice Medicine in a British Territory was asked to leave, (Continued on page 8)

GIFT TO SCHOOLS

TWO ANGUILLANS DETAINED.

Last week two Anguillans, Albert Gumbs and Charles (Charlie) Fleming both of East End, were detained at the Police Station. Mr. Gumbs who was picked up on Friday April 4th. was released later that day. Fleming was picked up on Saturday 5th. while taking water from the cistern at the public school at South Hill. It was reported that Fleming was taking water without permis sion but was later clarified by the Headmaster Mr. Adrian Hazel, that he gave him permission to take it. He was released the same afternoon. Fleming claimed that he was extensively questioned about firearms by the Police. Both homes of the two men were also searched.

DR. SPECTOR ASKED TO LEAVE.

Dr. Spector, a licenced Osteopath, has been asked by the Immigration Author ities to leave the island on Tuesday April 8th. The Immigration claims that Dr. Spector cannot practice Medicine under British Law and was asked to leave. Spector was Anguilla's Gov't. Doctor from July 1968 to Now when he was dismissed by the Anguilla Council. Later he was given permission to set up a private practice and this he has been doing ever since. When Dr. Spector arrived at the Airport to board the plane for St. Thomas, when was met with shouts from about 50 Anguillans not to leave the island. Spector was brought back to the Airport at 12noon where the crowd had been joined by another 50 persons who would not allow him to leave, and shouted "Tony Lee must go".

0.5 ANTI-TANK GUN FOUND.

The statement by Mr. Ronald Webster that H.M. Commissioner had breached the agreement reached by Lord Caradon, and that Mr. Tony Lee declared Marshal Law, seems to be based on a deliberate misunderstanding.

The Interpretation of the agreement signed by Mr. Webster and other members of the Council, made it clear that the

sland would be administered by H.M.Commissioner, in full consultation and superation with the Council, that would consist of the same seven men who ere duly elected in 1968. Item 4 specially says, quote, "The members of 1968 Council will be recognised as elected representatives of the peoand will serve as members of a council to be set up for the above pur ses." unquote. If Mr. Webster did not understand the document, he should y so If it is that he now realises that there is no office of "Chief ecutive" under the agreement, and would like to retain that office, then should impress upon Lord Caradon the necessity of a constitutional conference as soon as possible, to set Anguilla legally on a course with some rm of association with Britain. Meanwhile we see no reason why the island ould not be administered as agreed, until such constitutional agreements been reached.

The question of who is Commissioner should not arise at this stage; and ot us for the sake of the late and Noble Martin Luther King and for our lives, keep racial indifferences out of it. Mr.Lee we all know very well to be a staunch supporter of Anguilla's cause, this was said by Mr.Webster imself last October when he returned from the London Conference. He told us that Bradshaw had even accuse Mr.Lee of being bribed by Anguillans, ven at the end of last year, the council asked H.M.G. to allow Mr.Lee to main on the island.

He is now a victim of unfounded rumours that have been circulating in this Taland since the bogus Republic Constitution was introduced. Mr. Webster's other statement that the document that contained martial law was backdated to 19th March, but made made public after the agreement had been reached with Lord Caradon, is also untrue. The Beacon had a copy as of barch 24th, (before Lord Caradon arrived). It was given us by the associate editor of the Anguilla Observer, Mr.Clive Smith. It had been sent by Mr. Greatorex, Public Relations Officer. The Beacon was plublished on 31st March, after being out of publication for two weeks.) On the outset of this revolution, the aim of Anguilla was to seek some of association with Britain. Truthfully, the legal string with St.Kitts, is not yet broken, but we have secured a written undertaking from H.M.G. that they will not put us under an administration under which we do not want to live. They also agreed with us to consult other Carribean Gov'ts on working out a status for Anguilla. We should draw the line some place, and don't let the crave for power strangle us. Let us settle down for this initial period and assess the situation, and make plans for the type of Gov't that is best for us.

Contract Awarded:

The contract to put down the foundation for the 14 class room, Cosely Prefabricated School has been awarded to Mr.Hugo Rey, local contractor.

Hugo Rey, who bid \$32.000 was the only bidder when the school was put on bid last October. Last December, when the Interim Period was coming to an end, the Council voted against the errection of the School. After the foundation has been built, the Royal Engineers will complete the job.

STAMPS: The Anguilla definitive issue of stamps overprinted "Independence January 1969", was taken off sale at Valley Post Office on March 9th. A

total of 15,000 sets were overprinted and put on sale for 3 months, or until stock was exhausted. Values from 10¢down were sold out before March Jth.



DEVELOPMENT PLANS DISCUSSED.

At the first meeting of the Council with H.M. Commissioner held on Tuesday April 1st. '69, the Development plans were discussed. Before going into the Development Programme for the island, Mr. Lee, H.M. Commissioner, told the Council that as a result of presure by him and Lord Caradon, equipment for a permanent Radio Station for Anguillans and four Engineers to set it up had arrived the day before. Mr. Lee sought the Council's advice as to where the location would be. He then outlined the Development programme, which he termed as an extension of the preliminary programme left off in 1968. He said that £15,000 worth of Road equipment were ordered from last ear's development scheme, and the meeting agreed that priority should be given to the errecting of the pre-fab school. The Roads and a pier at andy Ground with a constant Depth of Fifteen Feet, he added, that the Engineers reported it might cost up to \$250.000 to errect. The Fouth priority on the list was water supply, and it was agreed that the spring at The north of Cauls Pond should be checked for the flow. The Fifth and sixth were Telephone and Electricity. It was decided that the Airport extension was not priority, but that the Engineers would spray the area around the Terminal Building, to reduce the dust. Another meeting was held on Thursday 3rd. with May Plummers, head of the Royal Engineers, who will do the work with local help. It was then decided that the next meeting would be on Friday 11th. April. All members of the Council were present except Mr. Colins Hodge, who is reported sick.

LORD CARADON TO VISIT AGAIN.

The British Representative to the U.N, Lord Caradon, was expected to arrive in Anguilla yesterday Friday. Commissioner in Anguilla, Mr. Tony Lee, of breaching the agreement reached by Lord Caradon and the Council on 30th March 1969. STONE FOR ROADWORK.

The Anguillan road construction programme is to be restarted shortly, and materials for it will be required. The first phase of work will be done in the following areas:— Long Bay village (300 yards) South Hill village and lower South Hill (2100 yards) White Hill (1300 yards) George Hill (1800 yards). Each 100 yards of road will need about 75 cubic yards of 2 inch stone, which will be called for and accepted only as and when required. Quantities delivered will be estimated and agreed, and payment made at \$5. per cubic yard. The stone should consist of clean hard rock particles, and approximately 60% should be between 2 inches and $1\frac{1}{2}$ inches in dimension.
