THE following extract is From the EXPRESS April 16th. 1969, written by EARL AUGUSTUS. "LAW AND ANGUILLAN CRISIS."

Whether it has been the tragedy of the Cadogan Affair, the inauthentic and repressive Industrial Stabilisation Act, the bloody excesses of Dr. Rodney's exclusion from Jamaica, or the recent turmoil in Anguilla, the responses of West Indian legal professionals, with very few exceptions, have been trivial and even dangerous. The recent pronouncements of Mr. Karl Hudson-Phillips, allegedly attached as legal adviser to Mr. Webster, secessionist leader of Anguilla, are important indications of this type of response. In a Press statement, Mr. Hudson-Phillips has said recently that: About 700 British military are distributed throughout the island of Anguilla. NSION. That there is mounting tension in Anguilla between the British occupation forces on the one hand and the whole or almost the whole body of Anguillan peoples. That this mounting tension is due primarily and olely to the presence of British occupation forces in Anguilla. "Mr. Webter," it is said, "insists that the presence of the British troops in willa is the only factor which is tending to produce a state of lawless wess on the island."

WOTIVES That the British Government have other and grave motives for the military investment of Anguilla, distinct from the stated official pronouncement that the investment was provoked by the activities of criminal angster like persons on the island. "Reports of Mafia-type control,"reouts Mr. Hudson- Phillips, "Have suddenly evaporated and the British," he are told, "are now attempting to win the confidence of Mr. Ronald Web er whose position politically in Anguilla continues to be unassailable." 'n a statement attributed to Mr. Webster, we learn that "this is the second time in less than two years that Anguilla has been invaded by British troops and that in June 1967 the British warship, HMS Salisbury, landed a detachment of 50 men in Anguilla. We are informed, however, that "this detachment emained only a few hours and was withdrawn when it was realised that there ere no gangster-type elements in Anguilla." In short, Mr. Hudson-Phillips as been concerned to portray the Anguillan crisis as a conflict in essence and primarily between the armed-might of a British Imperial government and gentle, though hostile, law-abiding Anguillans. It is a view which Dr. Williams, for instance, had been at pains to project in Europe and in spite of its brazen inauthenticity. But since it bobs up again in a lawyer's rief, it may be useful to examine the view once again in the framework hat Mr. Hudson-Phillips has presented it. We are compelled then to ask: DID not the Anguillan crisis owe a great deal of its tension to the violation or alleged violation of constitutional rights of Anguillan peoples by the Bradshaw administration? EVIDENCE.DID not members of the Judiciary of that administration declare

against undue interference by the Bradshaw regime in the legitimate affairs of the Judiciary? IS there not evidence that raiding parties attached to the regime and secessionist elements carried out hostile managaures one against the other, landing with armed men on one another's territory? WAS there not an attempt or planned attempt by Anguillan secessionists to seize Mr. Bradshaw himself as a hostage? WERE not native policemen, native public servants who had collaborated or appeared to have collaborated with the Bradshaw regime driven from Anguilla by Anguillan peoples and by the threat or use of force?

INTEGRITY. WERE not the Anguillan peoples opposed to an association with St. Kitts and Nevis as early as 1966 and preferred instead to have direct association with Britain? IS not the British Government (cont'd page 3)

MANIFESTO OF THE ANGUILLA CONSTRUCTIVE DEMOCRATIC MOVEMENT-

- 1. Re-affirmation of Anguilla's secession from St. Kitts/Nevis, and to work for the legal separation at the earliest possible time.
- 2. acceptance of the agreement made between Anguilla and the British Government on the 30th March 1969.
- 3. To accept a period of RECONSTRUCTION and APPRENTICESHIP in the Political Social and Economic Sectors of the community.
- 4. To work for the proper construction and preservation of a democratic system of Government.
- 5. NO INDEPENDENCE -- Anguilla is too underdeveloped, both in money, man-
- power and technical and administrative skills to maintain independence.
 6. ULTIMATE RESPONSIBILITY for the running of internal affairs of the isIand. "That is, INTERNAL self government."

DID not Caribbean Governments, include the Government of Trinidad and Tobago, urge on February 6th, 1969 and at a meeting of Heads of Government that Britain should"take all necessary steps in collaboration with St. Kitts-Nevis anguilla to confirm the territorial integrity of the Associated statehood?" IF, as the head of the Trinidad and Tobago Government indicated abroad, violence was not included or considered among "all necessary steps," what other necessary steps, apart from the use of violence, did Caribbean Heads of Governments consider at their meeting of February 6, 1969? Let us look at another report on the Anguillan crisis which appeared in the Observer of March 23, 1969 composed by six correspondents, one of whom reports from Anguilla. There we read: "The Government (British) appears to have relied exclusively on a resolution taken by Caribbean Prime Ministers on February 6 when they called on Britain "to take all necessary steps, in collaboration with St. Kitts Mevis-Anguilla, to confirm the State's territorial integrity. Again, in the same Observer repe ort, we note interestingly: "Whitehall now feels that some of the Caribbean leaders are willing to face up to the responsibilities of their own advice." And still further: "Because most Caribbean Governments face similar secessionist problems, they became seriously worried about Anguilla's rebellion. They worked to repair the breach." A breach, it seems, that many Anguillans are unwilling to bridge, preferring all the while from 1966 to the present, to be in direct association with Britain, at least temporarily, rather than as associated with the woeful Bradshaw regime or more significantly, with any of the independent Caribbean states. It is somewhat more than curious that Mr. Hudson Phillips attempted to blur over and indeed $\tilde{\eta}^{o}$ misrepresent the clear manifestations of the Anguillan crisis.

REPORT. Some understanding of the real currents in this crisis may be gained by reference to a decisive report on developments and people in the Caribbean. The report was written in 1939, following the wake of riots that struck the Caribbean from Jamaica to Guyana in that year. In the Mynoe Report of 1939 we read: " Serious discontent was often widespread in West Indian colonies during the 19th century, as is indicated by the occasional uprisings that occured, leading sometimes to considerable loss of life. "But the discontent that underlies the disturbances of recent years is a phenomenon of a different character, representing no longer a mere blind protest against a worsening of conditions, but a positive demand for the creation of new conditions that will render possible a better and less restricted life. " It is the co-existence of this new demand for better conditions with the unfavourable economic trend that is the crux of the West Indian problem of the present day." This warning and direction have been repeated by West Indian thinkers who share a certain responsibile concern for people and developments in the region. Mr. Hudson- Phillips is, on his

own assessment of events, not one of these.

Letter to the Editor- "KNOWLEDGE IS THE FOUNDATION OF FREEDOM" Anguilla today is moving towards progress not because of what the Government has done for the people, but what the people did for themselves. They have won a battle even without realizing it. Some of us see the British intervention as a shield from foreign aggression; Some of us see it as a turning point in Anguilla's history. Some of us see it as a social and economic revolution. Some of us even see it as a means of political equality for all Anguillans-rich and poor. We should consider ourselves lucky and give thanks to the Almighty God for guiding us to safety, even though our leaders made some serious mistakes. (Continued on page 6)

The do not over look the part played by Mr. Webster, and have praise for him. We was chosen to be the leader of our people, with the aproval of all, but his changing attitude must be remembered. The kind of people he associates himself with is an important factor, and we cannot say the same for them as we said for him. Some of his influencial backers now, were at one time at odds with him, and were even told by him, where to get off. They had dans beyond our scope. These people like most Anguillans had to travel abroad to make a living, but they did not see the necessity of taking colitical interest in their island. Instead they adapted the policy, if you can't beat them, join them, (Political Bosses in St.Kitts), so they poined them. But two male crabs cannot live in the same hole.

LETTER TO THE EDITOR. "DIPLOMACY"

I have followed the events taking place on Anguilla with great interest and ever since our revolution for self determination began in early 1967.

My constant search for up to date information has been hightened by the more recent turn of events; the landing of the British troops and the subsequent confusion over the course which Anguilla should take. I can say that although there is little that a hand full of Anguilla students can do here to cause dramatic changes back there, we did however organize, with the help of the Caribbean Students Ass., a march on the British Embassy in Washington D.C. at which time a document protesting the intervention of troops was submitted to the British Ambassador to the United tates. That document was signed by myself followed by a number of the ther Anguillan students and other sympathizers.

Since that time I have grown very disillusioned about the state of affirs which existed before the British came and now since they have stayed. Let me say that I had no doubt in my mind that better diplomacy could are been used by the British to acheive their aims. However, after reading an article in "The New York Times" concerning the constitution that was drawn up and accepted, I am saddened to think what would have happened to Anguilla, had not the British came. The space does not permit me to claborate, but suffice it to say- that constitution was absolutely ridictious, rotten, and clearly the work of either men ignorant of the ways of Government or those who clearly sought out-right exploitation of the "common people" of Anguilla.

I feel strongly, my people, that we need guidance, guidance that we can trust, and we shall have this guidance, if those who were intrusted with our lives recognize their inadequacks and seek professional help, before making rash dicisions, and ruining the reputation of a peaceful intelligent people.

Our leader, an "honourable man" I hoped, has diverted to the same irripponsible diplomacy that the British used, and can now do much by confining himself to regaining the unity of the Anguilla people, instead of disrupting at every stage an orderly institution of a recognized Government and a return to an atmosphere where all Anguil'ans will be free to persue their happiness. The "rebel government of Anguilla" for so it was named, was an"adventure", unrecognized by any other power on this globe, and we must realize that however iresponsible the Britis action was, the nally outcome can be a form of Government which can be accepted by other dations.
